Minutes of the October 12th, 2007 Meeting

The meeting was called to order at 2:00, Oct. 12th, by club president Fred Axelrod. Minutes from the last meeting were read and approved. Lea Peot gave the treasure's report. The club discussed putting an additional \$7000 into CD. Currently the club has \$31,726.92 in various bank accounts including CDs. After some discussion it was decided to wait and see how the season goes before putting additional money into a C.D. This will keep cash available for unanticipated expenses this ski season if needed, and the maturity date will coincide with other C.Ds. Axelrod suggested that he contact Dick Langer to audit the books which is required annually by the Club's constitution.

Johanna Axelrod brought up a suggestion from club member Jules Blank of offering an optional life time membership. The club discussed the advantages and disadvantages. The issue was tabled till the March meeting. Members were encouraged to find out if there are other organizations that have lifetime memberships, and how they work. Sandy Moore gave the membership report. Membership letters will be mailed out early November.

Lloyd Lundwall reported that the equipment is ready from grooming. Paul Rominesco reported that he did some maintenance on the equipment. He purchased some tools and parts for equipment maintenance. Bill Moore reported that the Kilometer signs will be painted with a yellow background so they will show up better when snow is on the ground. Trail clean up is almost complete. Axelrod reported that the US Forest Service still has **not** approved or disapproved the trail reroute on Highway F. This is after a request was made 1-1/2 years ago. The Forest Service is reportedly waiting to hear from the Chippewa Tribe on whether the site has cultural significance to them. Meanwhile the DNR is ready to donate dozer time which has been operated by the Langlade Forestry Technician, Ryan Brown for the last several years. If approval isn't received by November 1 this project is unlikely to happen this year. Some members felt it was time for club members to write letters to the Forest Supervisor or their elected state or US representatives if this is not approved for this year. Axelrod said he would report on this in the next newsletter. Axelrod brought up safety during clean up. He suggested the club purchase chaps and other protective gear for chainsaw use. Johanna Axelrod reported on trail maps. There are enough maps left from last year. A letter will be sent to advertisers giving them an opportunity to renew their ad., or make a donation in lieu of a new ad.

Shirley Bubholz said she would be in charge of the Chili Social again this year. March 1st was chosen for this years' event.

Tim Klima suggested the club recognize Mark Therrian for his many years of service to the club.

Tim Klima told about a roller and comb that could be used with the Scandic for early grooming. This could be purchased from ABR in Ironwood, MI. It would compact the snow during marginal snow conditions, and be less likely to bog down than the tidd tech. It would also compact the stubble as well as the snow, and shorten the grooming time. The cost for both would be about \$1,400.00. Bill Moore made a motion that we purchase the 61/2 foot roller plus comb. Tim Klima seconded the motion, and it was unanimously approved. Lea Peot made a motion that the cost of the roller and comb be reflected in the \$1,500 less being put in to the groomer replacement fund this year. Motion was seconded by Johanna Axelrod and it was approved.

The meeting was adjourned at 4:00.



Dear Lakewood skiers,

It seems every ski season is unique in what the weather brings. This year we received skiable snow on December 1, The earliest we've had since 1985. However, since then we have had two major rain events followed by an inch or two of snow. I was surprised and pleased that our trail held up well. Fortunately we had the Scandic and Tidd-tech plus our new roller which seemed to bring the trail to decent conditions. That we still have a skiable trail, today Jan. 12 is a tribute to the work of Lloyd and Tim who have been out grooming at the right times this year with the right equipment. Hopefully the remainder of the winter will make up for our snow debt.

On other matters the US Forest Service finally (after 1 ½ years) approved our proposed bypass on County Road F. We received this approval two days before deer season. Lloyd and I met with a forest service employee and marked the trees to be removed. However, with deer season and the early snow we were not able to get them cut this year. We may be looking for an early spring work detail to get these trees cut so we can bring in the DNR dozer (thanks to the forestry crew at Langlade Ranger Station) to remove stumps and level the trail.

The slow response by the USFS, our need to renew our permit with the Chequamegon/Nicolet National Forest, the annual donation of dozer time by the DNR, and changing personnel in the Oconto County Forestry Department who donate the mowing of our trails have caused me to contemplate our relationship with government agencies we deal with. I think we need to renew our relationship with these agencies and be more proactive. We need to make them aware of our benefit to the community and how working with us helps them to meet their objectives. We also need to make sure they are aware of how they can help us provide a world class cross country ski trail. I am looking for club members who are willing to serve on a committee to review our intergovernmental relations and perhaps to negotiate with these agencies. If you feel you can contribute to this effort let me know (715-276-9942).

There is still plenty of winter left so I hope to see you on the ski trail and at our Ski Social on March 1.
